# Why Compare Public Policies?

- Comparison places the status quo in perspective.
- Comparative public policy can help us to understand and explain why divergent policies are adopted in different contexts, and why they lead to a variety of outcomes.
- Comparison implicitly places nations in competition with each other.








# Abortion Law Divergence in US States

# Policy Divergence and Convergence

- Even amongst relatively similar countries with apparently identical aims, we find radically divergent policy approaches.
- National, regional and local governments thus adopt a bewildering variety of approaches towards similar policy problems.

# Dimensions of Comparison

- Geographical Dimension
  - Comparing policy in different nations
- Time Dimension
- Technological Dimension



## **Examples of Dimensions**

- Time Dimension
  - What can we learn about how to deal with pandemics from the COVID-19 experience?
- Geographical Dimension
  - What did Turkey learn from other countries during the COVID-19 Pandemic?
- Technological Dimension
  - What can be learned from the simulation of disaster response policies regarding natural disasters, such as earthquakes?



# Why Are Policies Different Across Nations?


- Policies, the stakeholders involved in designing and delivering them, and policy outputs and outcomes, vary significantly across nations.



### **COVID Vaccination Differences**










